Your membership entitles you to display your work in our Art in Public Spaces Program. We are pleased that you have agreed to participate in this exceptional opportunity which benefits the community and fulfills our CBAA mission to promote community interest in the arts.

1. The ARTIST is responsible for delivery, and sometimes with hanging and takedown of their art at the designated place, date, and time indicated below. We will assist with the hanging. Please include ONE business card with each piece (1 attached to the front) showing medium, title, price and if it is an ORIGINAL or a PRINT.
2. Business cards ONLY are to be displayed with work; anything else will be removed by the Chairperson.
3. All 2-D work is acceptable. Work must be properly and securely framed and wired for wall hanging. Heavy and large pieces should use Plexiglas rather than glass. Weight must be less than ten pounds
4. All sales will be handled by the ARTIST. The artist is responsible for his/her sales tax.
5. There is no fee for displaying your work. However, for handling and for this professional opportunity provided to you, CBAA will greatly appreciate a donation of 10% of the sale price of any work sold as a result of the display be given back to CBAA. This of course is by the “honor system”.
6. NOTE: Hanging art in public places is always a RISK. Neither CBAA nor the exhibiting establishment will be responsible for any loss or damage of the art while on display.

**YOUR DISPLAY:**

Criteria for Art Displays

Copyright Free, Suitability of subject, technique, and style for all audiences including children and adults. No nudity, No profanity, No advertisements or commercial exhibits, No partisan political exhibits or exhibits that support the election or defeat of a political candidate. No exhibit shall violate any law. No pornographic or obscene exhibits, or exhibits deemed derogatory or offensive to civil standards. No exhibit shall defame any individual or group regarding religion, sex, sexual orientation or gender identity, marital status, disability, color, national origin, or race.
